## **Consent to Medical Treatment**

It is understood that my authority is given to the Lexington Chinese School (LCS) officers and teachers (any one of them) to have myself and/or my child treated for any illness or injuries we incur or experience during any session or activity of LCS. ## **Release of Liability and Indemnification**

I hereby release and discharge LCS, its officers, teachers and representatives, including parents on duty, from all obligations and/or liability resulting from accidents, injuries or otherwise occurring during my or my child's participation in or attendance at any LCS session or activity. Further, I agree to indemnify and hold harmless LCS, its officers, teachers and representatives, including parents on duty, against all expenses, obligations and/or liability resulting from injury to persons or damages to property that occur as a result of my or my child's action during any LCS session or activity.

## **Publishing and Promotional Media Authorization**

I understand that, from time to time, LCS intends to display student pictures and student projects on its website and that LCS may, but is not obligated to, include my or my child's first name (only) and grade level along with such display. ## **Tuition Policy**

Unless otherwise approved by the LCS Principal, tuition for the semester is due in full by the second Saturday of classes for that semester. A late fee of \$20.00 will be applied if tuition is not paid in full after four (4) weeks from the first day of school.

Any student, who withdraws from LCS prior to the sixth week of classes, may receive a refund of his/her tuition less a pro rata portion for the classes that have already been conducted. Any student who withdraws from LCS on or after the sixth week of classes is not entitled, and may not be given, any refund of tuition.
